Release and Waiver

In consideration of being allowed to participate in any athletic/sports event sponsored by the Muhlenberg Township Athletic Association (MTAA), and any related events and activities, and intended to be legally bound, the undersigned :

1. Agree that the parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating he or she should inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he or she should immediately advise his or her coach or supervisor of such condition(s) and refuse to participate.
2. Acknowledge and fully understand that each participant, adult or minor, will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence, but also from the actions, inactions or negligence of others, the rules of play, or the conditions of the premises or of any equipment used and further acknowledge and fully understand, that there may be other risk not known to us or not foreseeable at this time.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
4. Release, waive, discharge and covenant not to sue MTAA, its affiliated clubs, their respective administrators, directors, agents, coaches, attorneys, and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event, all of whom are hereinafter referred to as " Releases", as to and/or from any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the Releases or otherwise.
