- Hip also gave Kelli a photo of all the girl's teams, to be given to Frank. They discussed hanging it somewhere, where it can be seen.
- Hip mentioned the few issues they had this year: a few fan problems, and a coaching issue on the "upper level". He hopes this was all taken care of, and feels the season was "overall decent".

**Wrestling** given by commissioner, Jon Moyer

- They've reached the end of the season, beyond a few kids practicing yet this week.
- He would like a few days of practice per week in March for the few kids in Nationals and States.
- March 17<sup>th</sup> is their banquet, at 1:00pm, at Laurel Commons.
- They would like to approach the board in the near future regarding a tournament next year. He feels there may need to be a separate meeting due to it being such a big process. He stated Daniel Boone profited \$12,000-\$18,000 from their tournament. They would need at least 100 people to help run it. Ideas for dates are Thanksgiving Weekend, and the Sunday around Christmas. Doug Brown gave info to Ted regarding shirts. Chris Evans requested to be allowed to get a quote on the shirts as well. They are thinking of calling it "MTAA Massacre on the Mats".

- Kelli asked to add the Executive Meeting agenda the possibility of a Fall Softball League. She said Tim Moyer is interested in coaching. Sign up's would be with Football. The league would have to know for sure by August. The sport would need a commissioner. It would be a travel league.

#### **Baseball Report** given by commissioner, Kelli Miller

- So far, 205 kids have signed up. 61 kids at the tee-ball level, 54 for coach pitch, 36 for knee-hi, 29 for mites, 13 for JDL and 12 for DL.
- Evaluations went "amazing". There were no issues this year with who made the team, and who didn't.
- The JDL tournament's anticipated dates are May 31<sup>st</sup>, June 1<sup>st</sup> and June 2<sup>nd</sup>. \$375 fee.
- Sign-ups close on March 15<sup>th</sup> (except for the travel teams, which have already closed).
- Kelli noted having 263 kids last year, which means the numbers are down slightly. She requested that Don send an email blast letting everyone know she will be at CE Cole on March 2<sup>nd</sup> for additional sign-ups.
- Uniforms will be a little different this year. Socks and pants will be included to keep with the uniform. She would like "Muhlenberg" on the uniform, instead of just the logo for the professional team they are representing. 1ballsports will be contacted for the tee's. Chris Evans again requested to be given the opportunity to get a quote from the vo-tech as well.
- Jon Moyer asked when the teams and coaches will be picked. Brad hopes by April 1<sup>st</sup>.
