Baseball Report given by commissioner, Kelli Miller

- Sign-ups were this past weekend. They currently have 53 kids for Tee-Ball, 39 for Coach Pitch, 22 for Knee-Hi, 18 for Mites, 17 for JDL and 18 for DL.
- In-house evaluations are March 17th, JDL evaluations are Feb 14th and DL evaluations are Feb 13th.
- They are now only allowed to use wooden bats. Kelli will have a meeting to find out if there are any specifications for the wooden bats. Kelli is asking the board to approve the purchase of a few wooden bats, to have to show parents as examples of what to purchase and incase someone would break their bat at game.
- The DL coach had to be selected already. The JDL coach was not going to be named until
 after the team was selected to avoid past conflicts. Kelli petitioned the board to reverse this
 rule. The board majority vote was Yes. Kelli sent an email to report Erik Keiper has been
 named Head Coach. The Assistant Coaches will not be picked until after evaluations.
